The further qualification being the Ordinary Member on the Executive will be elected by the Board (please see New Constitution 4.4(d)).

# **Special General Meeting Motion**

The Board provides the attached motion to be considered at the above mentioned Special General Meeting. The motion provides for the adoption of the new Constitution and other special resolutions to provide transition. The two key transitional items are proposed to ensure operations of the APSI continue. As has been in the past and to provide future stability the terms of the President and Treasurer are staggered by 2 years. The term of the President is due to expire at the APSI's Annual General Meeting 2020 (**AGM**). In this case, the initial term of the Treasurer will be two years and thereafter 4.

# **Transitional Process**

In the event the membership votes to adopt the new constitution and therefore the new composition the following processes will occur:

- each current Board member to resign following reporting to the AGM
- nominations of all new Board members to be received two months prior to the AGM
- nominations may include a written background and proposal, photo and video of the proposed board member
- nominations will be made available to all Members
- online voting to commence in the month prior to the AGM
- online voting, proxy voting and physical voting to be tallied and verified at the AGM
- adoption of new Board at AGM 2020

The current board is unanimous in its recommendation to the members to adopt the proposed constitution. The recommendation is not only voiced by all board members but also in action as all current serving members will resign to see the adoption occur.
